
Today, Alberta's deceased organ donation rate lags behind other provinces, the Canadian average, and is well below other developed countries and jurisdictions.



ALBERTA CAN BE A LEADER

A) A UNIFORM SYSTEM – MORE EFFICIENT AND EFFECTIVE DELIVERY

- Alberta is the ONLY province in Canada with two Organ Donation Organizations (ODOs).
- Economies of scale can be realized with a single agency (i.e. lowering overall costs per transplant patient and increasing donation and transplantation system efficiencies).
- Without a uniform, integrated system, we will continue to have missed donor opportunities in both our rural and urban*2 hospitals and have varying kidney transplant wait times between Edmonton and Calgary.
- A single Organ Donation agency and voice will increase Alberta's participation at important National and International tables.
 A single structure for donations is consistent with Clause 12 of the Alberta Human Tissue and Organ Donation Act. The Act was unanimously passed by the Alberta Legislative Assembly in 2013.

B) MANDATORY REFERRAL AND AUDIT

One integrated system for mandatory referral, audit, public reporting, and culture change is essential, and a key part of success in other jurisdictions.

C) A STRONG/FRIENDLY PUBLIC EDUCATION, AWARENESS AND ENGAGEMENT PROGRAM

• An integrated, system-wide education and awareness program is vital, as demonstrated in successful jurisdictions.

D) VERY MODEST INVESTMENT TO SAVE LIVES AND SAVE MONEY

An amount of \$23 Million is needed to facilitate the "Laggard to Leader" changes. In addition to the increase of Donors per Million Population (DPMP) (i.e. 35-45 DPMP), as well as substantial incremental number of lives saved (i.e. approx. 1400-2700 in 10 years), there will be substantial money saved to AHS (i.e. directly, over \$100-\$400 Million in 10 years), and a further approximate net benefit to Alberta's economy of \$60 Million+ (excluding Value of Life), depending on model assumptions.

OUR ASK

The path forward requires a resource re-allocation commitment of *\$25 million dollars (over 3-5 years) to implement evidence-based policy changes which will save money and save lives

Presumed Consent & Registries


- Advocates of presumed consent tend to count all members of the general population as potential donors. However, this is misleading because few individuals will ever be in the situation of being considered for organ donation upon their death (~1-2%).
- Proponents of donor registries (databases containing the names of individuals who wish to donate their organs after death) also suggest databases better reflect the donor pool.
- As with the general population, this is not strictly true, because the number of individuals
 who ultimately become available as possible donors ("potential donors") is a small
 fraction of those who may be interested in becoming a donor ("intended donors").
- That said, online registries and registering as an organ donor IS a great way to start the conversation with your family and friends.

A WORD OF CAUTION

- Albertans who are 18+ can register as an organ donor via the online Organ and Tissue Donation Registry, at a registry office, or by signing the back of their healthcare card.
- However, we know not everyone is asked about their intentions to donate at registries, despite legislation mandating this.
- There isn't enough public education. Often, individuals are first introduced to the conversation at this point of contact and quite frankly, this doesn't allow individuals to make an informed decision.
- Registering your intentions to Alberta's online registry does not ensure your wishes are being honoured.
- Even if you have followed those steps, organ donation will only proceed if consent is received from the family. If there is disagreement among the family, donation will not proceed.
- In other words, REGISTERING YOUR WISHES IS NOT ENOUGH!!

Note: Both presumed consent and online registries can be useful tools to <u>compliment</u> organ donation and transplant policy only <u>AFTER</u> Alberta's procurement system has implemented the above policy changes.

START THE CONVERSATION

Talking about organ & tissue donation can be difficult, but with the right tools, you can start the conversation.

CONTACT YOUR MLA

I am writing you today on behalf of the thousands of Albertans waiting for an organ transplant, for those waiting for a life altering tissue donation, in honour of the thousands who have died while in need of an organ transplant, and in recognition of the hundreds of thousands of Albertans who have selflessly registered as organ donors.

Every day, thousands of Albertans are needlessly suffering, and many die because of Alberta's inaction on organ donation. This is unacceptable. As a member of Alberta's transplant community, I've seen how organ failure and organ donation impacts the lives of our loved ones. Organ donation is the ultimate gift of life, but more is needed to ensure there are no missed donor opportunities. Why? Because one donor can save the lives of up to eight people and improve the quality of life of another 75. Our current system has failed too many. Frankly, I need the government to implement an organ donation and transplant system that successfully and purposefully makes organ donation a priority, so the lives of those on a transplant waitlist can be saved.

The former Minister of Health, Tyler Shandro, took steps forward on this file. See below for list of achievements in 2021. However, more work is needed and we know the following changes align with our shared goal for MoreTransplants.

- Establishment of a pan-Alberta system with dedicated full-time leadership, ensuring accountability within the current structure.
- Legislation Amendment (replace Mandatory Consideration with Mandatory Referral) and implementation of provisions of the Human Tissue & Organ Donation Amendment Act.
- Create a Culture of Organ & Tissue Donation improve public awareness of the need and benefits of organ

OUR SINCERE THANKS FOR ADDRESSING THE FOLLOWING CRITICAL STEPS ACHIEVED IN 2021:

- Implement continuous and Real-Time Audits, as an essential best practice in urban and large rural centres.
- Provide dedicated donation and transplant facilities (prioritized OR access) consistent with best-performing iurisdictions.
- Ensure a User-Friendly Donor Registration System.

Minister Copping, these are the steps needed to embrace innovative, sustainable, comprehensive, and lifesaving change to Alberta's organ & tissue procurement system. These policy choices are attainable, evidence-based, and can be implemented in Alberta. Anything less is a band-aid solution that will provide minimal improvement to a system that is already overstretched. You can be the leader who does not accept mediocrity, but rather, has the vision to strive for a greater future for all Albertans.




